We invest the capital raised in research projects, startups, SMEs and venture capital funds to generate a return for investors.

Specifically, we operate through the management of two types of funds:

Indirect Investments

(or Funds of Funds) They invest in supervised European fund managers which, in turn, raise additional capital, thus generating a multiplier effect on the invested resources in order to support the emergence and development of specialised investors in the Italian venture capital market as well as the growth of the sector's financial infrastructure.

Direct Investments

They invest directly in selected startups and innovative SMEs, each with a differentiated approach based on the maturity level of the target startups and the relevant investment phase, in order to support the development of innovative companies and startups active in areas and technologies that are strategic for Italy.

THE 2024–2028 STRATEGY

- ◆ Focus on investments in 7 priority areas for the Italian economy: AgrifoodTech, SpaceTech, Healthcare & Lifescience, CleanTech, IndustryTech, InfraTech & Mobility, AI and Cybersecurity;
- ◆ Centrality of AI and cybersecurity, in line with the National Strategy for Artificial Intelligence;
- ◆ Active role as a partner of our investees to support value creation in the portfolio;
- ◆ Promotion of fundraising by private investors.

INVESTMENTS FOR STRATEGIC SECTORS

In order to promote Italy's growth through our investments, we conducted a strategic analysis that allowed us to identify the most relevant sectors assessed on the basis of market maturity, strategic nature for the country and the relevance of technological innovation in the sector in question.

We then outlined the 7 *priority areas* on which we will focus our direct investments in the period 2024-2028.



SUPPORTING THE NATIONAL STRATEGY FOR ARTIFICIAL INTELLIGENCE

€1 bn in 2 areas:

€500 m

to create a dedicated Artificial Intelligence fund to develop innovative technologies.

€500 m

in joint investment with the other funds managed by the Asset Management Company, to support companies already using artificial intelligence in their projects.

In detail:

€120 m for Technology Transfer, to link the research to the market

€580 m for companies working on specific applications

€300 m to create 2-3 examples of national excellence.

PORTFOLIO VALUE CREATION

We adopt a selective approach, focusing on the areas of greatest strategic interest to attract top talent and expertise, in Italy and worldwide.

We invest in the ***most promising businesses*** and accompany them along their growth path with resources, expertise and a solid network of connections.

THE IMPORTANCE OF FUNDRAISING

We strive to attract resources from private entities by adopting a 'crowding-in' approach, which generates an additional and complementary effect within the market. This is achieved through:

- ◆ the development of attractive products consistent with market trends;
- ◆ expanding our investor base;
- ◆ the use of public resources and the amplification of private raising of capital by the market.

OUR INVESTMENT STRATEGY

Our investment activities aim to improve the national venture capital ecosystem and attract new investments precisely to accelerate its growth. Investments are made through:

- ◆ Supporting the Italian Venture Capital infrastructure, through investment in pre-seed and seed startups and in venture capital funds to nurture medium- and long-term market growth and skills to support innovation;
- ◆ A strong stimulus to the development and growth of the ecosystem, through direct investments, specialised by sector, in the development stages – early stage and late stage – to support the projects of Italian startups in the most strategic sectors and technologies for the country;
- ◆ Investments in funds to build the Italian Venture Capital financial infrastructure, with resources and expertise to support the growth of Italian startups and SMEs, including through indirect funds of funds investments.

Technology Transfer FUND

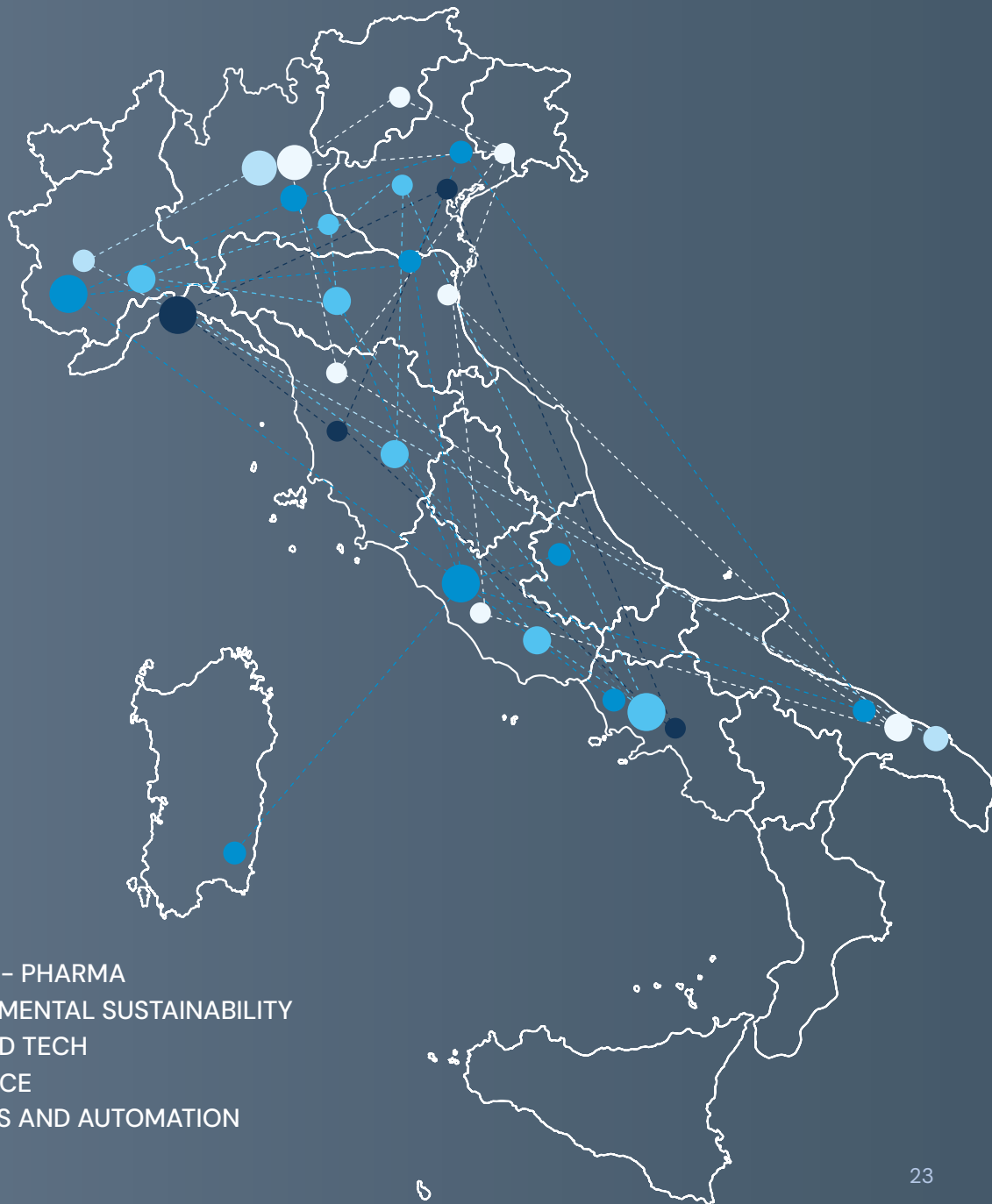
The Fund enhances the value of market research results, through the creation and development of deeptech startups, specialised in the scientific and technological fields with the highest potential for the competitiveness and innovation of the Italian industrial system. The aim is to reduce the gap between the research lab and the market, by adopting and supporting projects with high innovation potential over time and creating integrated ecosystems involving universities, corporations and business partners.

To do this, the Technology Transfer Fund invests in two directions, through separate dedicated segments: directly, by setting up National Technology Transfer Clusters, in collaboration with universities and research centres, to foster the emergence of startups; and indirectly, by investing as a subscriber in Local Tech Transfer Funds specialised in the same areas of scientific and technological research.

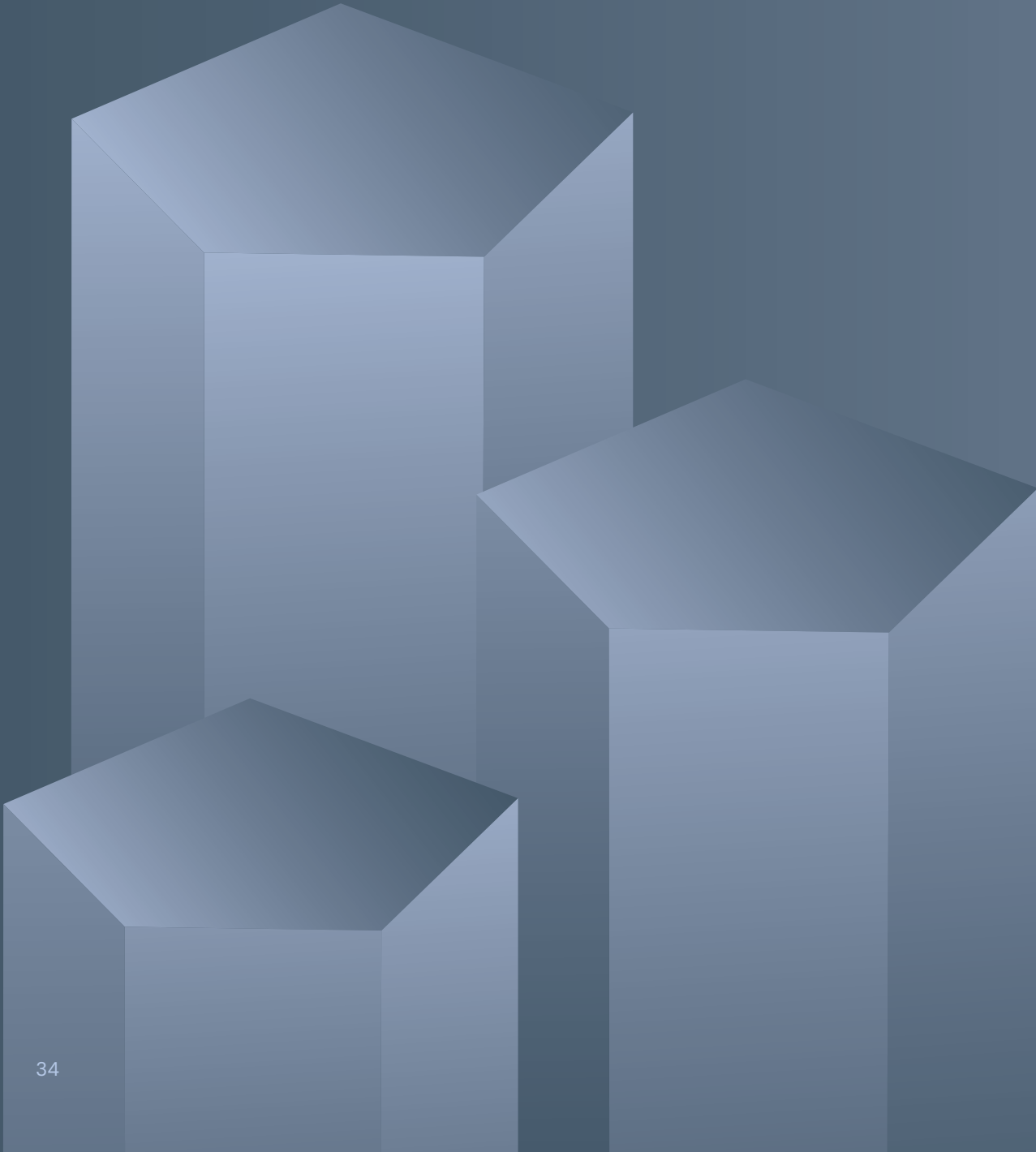

Corporate Venture Building Fund that co-creates new companies with corporations, with the aim of jointly entering into strategic sectors for both the enterprises in question and for the country. In addition, the Fund supports the digitisation and innovation of SMEs in strategic sectors with the involvement of corporate sector leaders. The Fund plays a key role in business creation through the development of the value proposition, business plan and team building. It invests in areas such as Advanced Manufacturing, Education and Training, Smart Health, Sustainable Mobility and Ecological and Digital Transition.

As of 2023, the Fund has expanded its investment policy to include the development of venture building activities to support the country's strategic sectors, with a focus on sectors such as Navigation/Ports and Agrifoodtech.

Ours is a *big world*, a special network of connections that to date counts more than 250 partnerships and collaborations and involves institutions, companies, universities and research centres and operators in the sector to:

- ◆ support the development of Venture Capital through programmes and capital dedicated to specific portions of the market;
- ◆ foster the exchange of knowledge and skills between companies and startups to enrich both parties;
- ◆ value research projects, scientific expertise and intellectual property;
- ◆ share best practices with all those working in the sector to fuel important growth mechanisms.

We manage capital that comes mainly from CDP Equity and the Italian government, but also from other sources such as banking foundations, local institutions, social security funds and companies. We have also activated agreements with public bodies and local institutions in order to increase the impact of our investments on specific sectors and territories, creating co-investment mechanisms that maximise the resources allocated to innovation.

An example of this is the agreement with the Italia Space Venture fund, financed with resources from the complementary fund to the National Recovery and Resilience Plan (NRRP) for investments in the aerospace sector, or the agreement with SIMEST for joint investments dedicated to supporting the international growth programmes of Italian startups, or the Piemonte Next and Toscana Next funds, fuelled by resources from local players, which systematically co-invest with our funds on initiatives originating in the territory and deemed worthy of a further boost to grow.
